

AVANQUEST UK LIMITED TEXT MESSAGE SERVER LICENSE AGREEMENT

This is a legal Agreement between you, the end user (LICENSEE) and AVANQUEST UK LIMITED (AVANQUEST). BY OPENING THE SEALED DISK PACKAGE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, YOU SHOULD PROMPTLY RETURN THE UNOPENED DISK PACKAGE AND THE ACCOMPANYING ITEMS (including written materials, binders or other containers) TO THE PLACE WHERE YOU OBTAINED THEM FOR A FULL REFUND.

- 1. GRANT OF LICENCE** - AVANQUEST grants you the right to use the enclosed software program(s) for the number of users specified on your purchase order.
- 2. COPYRIGHT** - The SOFTWARE is owned by AVANQUEST and its suppliers and is protected by United Kingdom copyright laws and International treaty provisions. Therefore, you must treat the SOFTWARE like any other copyrighted material except that you may either (a) make one copy of the SOFTWARE solely for backup or archival purposes, or (b) transfer the SOFTWARE to a single hard disk provided you keep the original solely for backup or archival purposes. You may not copy the written materials accompanying the SOFTWARE. LICENSEE agrees not to remove any copyright notices or proprietary legends contained on any diskettes of AVANQUEST and/or its suppliers.
- 3. OWNERSHIP OF SOFTWARE** - As a LICENSEE, you own the magnetic or other physical media on which the SOFTWARE is originally or subsequently recorded. AVANQUEST reserves the right and title to this SOFTWARE product, and all subsequent copies including title to this SOFTWARE program. You have purchased only a licence to use this copy, which is licensed to you by AVANQUEST. AVANQUEST OWNS THIS COPY AND ALL BACKUP COPIES OF THE SOFTWARE PROGRAM; YOU ONLY HAVE THE LIMITED RIGHTS GRANTED BY THIS LICENCE.
- 4. USE RESTRICTIONS** - As a LICENSEE, you may physically transfer the SOFTWARE from one computer to another provided the SOFTWARE is used in accordance with the terms of your purchase order. You may not distribute copies of the SOFTWARE or accompanying written materials to others. You may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the SOFTWARE. You may not modify, adapt, translate, or create derivative works based on the written materials without the prior written consent of AVANQUEST.
- 5. OTHER RESTRICTIONS** - This SOFTWARE is licensed only to you, the LICENSEE, and may not be transferred to anyone without the prior written consent of AVANQUEST. Any authorised transferee of the SOFTWARE shall be bound by the Terms and Conditions of this Agreement. In no event may you transfer, assign, rent, lease, sell, or otherwise dispose of the SOFTWARE on a temporary or permanent basis except as expressly provided herein. ALL RIGHTS NOT EXPRESSLY GRANTED TO LICENSEE ARE RESERVED BY AVANQUEST. LICENSEE agrees not to export or re-export any of the SOFTWARE without the appropriate United Kingdom or foreign government licences.
- 6. TERM** - This Licence is effective until terminated. You may terminate the Licence at any time by destroying the SOFTWARE program together with all copies, modifications and merged portions in any form including all written materials. THIS LICENCE WILL TERMINATE AUTOMATICALLY WITHOUT NOTICE FROM AVANQUEST IF YOU FAIL TO COMPLY WITH ANY PROVISION OF THIS LICENCE. You agree upon such termination to destroy the SOFTWARE program together with all copies, modifications and merged portions in any form including all written materials.
- 7. GENERAL** - This Agreement is governed by the laws of England. This is the complete and exclusive statement of the Agreement between you and AVANQUEST and this Agreement supersedes any prior agreements or understanding oral or written, with respect to the subject matter of this Agreement.

LIMITED WARRANTY

AVANQUEST warrants that the SOFTWARE or its reasonably contemplated use does not infringe any patent or copyright of any third party. THE SOFTWARE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND OTHER THAN THOSE CONTAINED IN THIS AGREEMENT. AVANQUEST DOES NOT WARRANT THAT THE PROGRAM WILL MEET YOUR SPECIFIC REQUIREMENTS OR THAT THE OPERATION OF THE PROGRAM WILL BE UNINTERRUPTED OR ERROR FREE. HOWEVER, THIS AGREEMENT AND ITS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS.

AVANQUEST warrants to the original LICENSEE that the disk(s) on which the SOFTWARE is recorded is free from defects in materials and workmanship under normal use and service upon date of delivery. AVANQUEST warrants that the SOFTWARE shall substantially comply with the current documentation upon the date of delivery. If the SOFTWARE fails to comply with current documentation, AVANQUEST shall use its best efforts to correct any reproducible error or malfunction in the SOFTWARE as soon as is practicable following notice from LICENSEE to AVANQUEST of such error or malfunction.

AVANQUEST'S entire liability and your exclusive remedy shall be, at AVANQUEST'S option either (a) the replacement of any diskette not meeting AVANQUEST'S "Limited Warranty" and which is returned to AVANQUEST with a copy of your receipt ; or, if AVANQUEST is unable to deliver a replacement diskette which is free of defects in materials or workmanship, you may terminate this Agreement by returning the SOFTWARE, and your money will be refunded.

If failure of any diskette has resulted from accident, misuse or misapplication, AVANQUEST shall have no responsibility to replace the diskette or refund the purchase price.
